

Dear Member,

Re: Personal Data (Privacy) Ordinance

As required by the Personal Data (Privacy) Ordinance, we hereby notify you that the information supplied on the Form and otherwise in connection with your participation (including but not limited to the information on this Form, any investment allocation provided from time to time and any accrued balances) in the Scheme may be held by the Trustee and will be used for the purposes of processing and administering your participation in the Scheme, carrying out your instructions (if applicable) or responding to any enquiry purporting to be given by you or on your behalf, dealing with any other matters relating to your participation in the Scheme (including the mailing of reports, notices or material relating to the Scheme) and including but not limited to being disclosed or transferred to and used by the employer (or a related company of the employer) for the purposes of calculating such employer's long service or severance payment accrued liability at any time or any other purpose, forming part of the records of the recipient as to the business carried on by it, observing any legal, governmental or regulatory requirements of any relevant jurisdiction (including any disclosure or notification requirements to which any recipient of the data is subject). All such information may be retained after you have ceased to participate in the Scheme to the extent permitted by law. While it is not obligatory for a member to supply the data requested, but failure to provide any information requested may result in the Trustee being unable to provide services to such member.

The Trustee may disclose and transfer such personal information, for the purposes mentioned above in connection with the Scheme, to the auditors or actuaries (if any) of the Scheme, any service provider (which may include a fund manager of any collective investment scheme in which the Scheme invests), the ultimate holding company, subsidiaries and/or affiliates of the Trustee, including any of their employees, officers, directors and agents, any third party employed to provide administrative, computer or other services or facilities to the Trustee, and/or the employer or a related company of the employer, which persons may be persons within or outside Hong Kong. The Trustee may also disclose and transfer such information to any regulatory authority, court, judicial body or other entity entitled thereto by law or regulation (whether statutory or not).

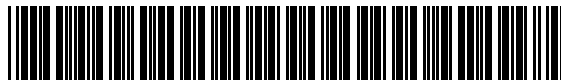
