United States

Association of Public Safety Communications Officials

The association's scholarship program will financially assist public safety communications professionals to obtain training in their chosen field.

Black Chief Officers Committee

The committee will provide executive development training to minority officers aspiring to become chief fire officers, fire chiefs and emergency service leaders.

Border Patrol Foundation

The foundation will provide higher education scholarships for the children of fallen, active duty and retired Border Patrol agents.

Central U.S. Earthquake Consortium

The consortium will provide building inspectors with safety assessment training, emergency managers with a standardized awareness of daily disaster operations and safety awareness and preparedness education to community members.

Coast Guard Auxiliary Association Inc.

The association will provide training for incident managers nationwide, regional fire extinguisher training for boaters and paddle craft identification.
