



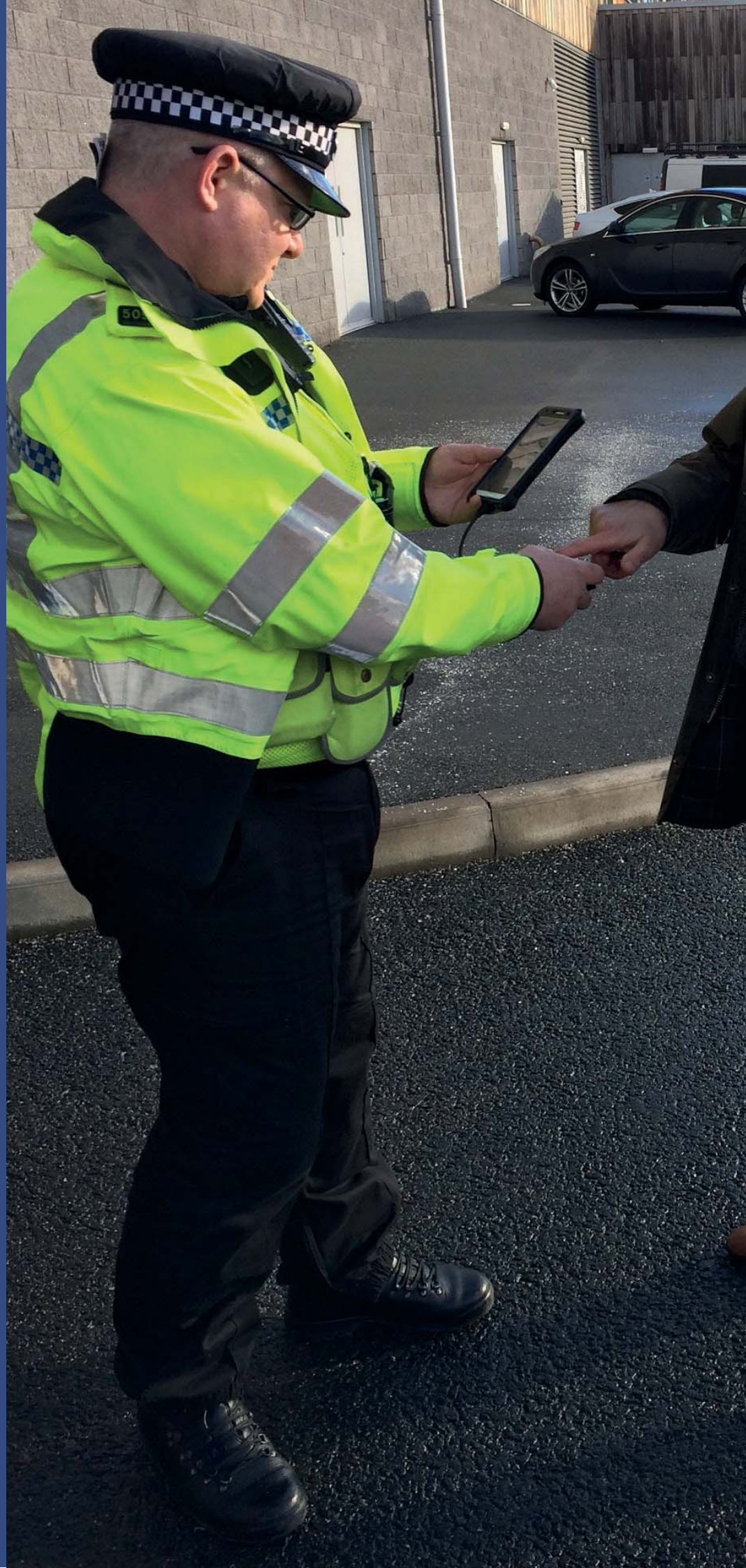

EASY INTEGRATION WITH EXISTING PRONTO EQUIPMENT

The Integrated Biometrics Colombo finger-print reader is one of a range of devices which Pronto integrates with in order to provide a search.

The Motorola Solutions Pronto Biometric Gateway is fully integrated into the Pronto E-Notebook and complements the federated person search capability Pronto provides to the user. In addition, the Pronto Biometric and PNC capability is available as a specific piece of functionality that can sit alongside any other existing mobile solutions. The biometric reader connected to the device allows comprehensive identification of a subject.

TECHNICAL INFORMATION

Pronto Biometrics meets all Home Office requirements for searching:

- Must capture 2 fingerprints to search
- Prefer left and right index
- Skip missing fingers
- Option of middle finger or thumb
- Fingerprint quality—score from 1 (best) to 5 (worst)
- Require one retry on score of 3—5
- Can search with score of 3—5 but slower with less chance of match

The Biometric Services Gateway (BSG) is a single point of access to biometric services from the Home Office Biometrics (HOB) programme, exposing services using a standard interface (HONBE-1). The BSG performs transport/message translation to provide homogenous access to all underlying services. This approach allows interfaces with external systems to be loosely coupled with HOB. Given direct HOB ownership, it also provides a constant interface, abstracting any supporting service/contract/technical changes. The BSG applies authentication and authorisation measures. Integration via the BSG is through an agreed interface specification and codes of connection. The BSG also performs usage, health and accounting reporting.
