Event playback	Watch footage from multiple body cameras and in-car video systems simultaneously, side-by-side. View metadata from your patrol vehicle - including speed, location, and lights and siren status - beneath the video.
Cases	Link footage from different devices into one file for ease of sharing. Add further metadata via customizable tags and notes.
Case attachments	Add more context to a case with third-party documents, videos and images.
AI-powered redaction and transcription	<p>Protect sensitive information - such as faces, bodies and number plates - easily with our cloud-based AI-powered redaction tool. Automatically detect objects, and quickly mute or beep audio with a drag-and-drop interface. Preview redacted footage in real time before export.</p> <p>With automated transcription, you can jump straight to the relevant section of a video without needing to review the entire video in real time.</p>
Sharing	Share media and incidents internally (via permissions and restrictions) or externally (via time-sensitive, password-protected links on our CLOUD-SHARE platform).





## DEVICE MANAGEMENT

Device dashboard	See a detailed, easy-to-understand overview of your body cameras and in-car video systems at a glance, including their battery levels, memory levels, last checkout, and location.
Device configurations	Configure multiple aspects of camera behavior. Options for body cameras include LEDs, haptic feedback, pre-record and button gestures. Options for in-car video systems include camera stream resolutions and automatic recording triggers.
In-field tagging	Categorize and review body camera footage while still in the field, via the SmartControl iOS/Android app.
Live streaming	Access real-time body and in-car video device locations, plus live streaming to put eyes on the scene of the incident remotely, with CommandCentral Aware. CommandCentral Aware unifies your real-time data and video streams to give your agency a shared common operating picture.

## USER MANAGEMENT

Roles, groups and permissions	Enable granular permissions for individual users and groups to control all possible actions on the system.
User import and synchronization	VideoManager EL imports users from your agency's instance of Azure AD to ensure joiners and leavers are automatically accounted for.

# Keep your data safe and compliant

Your confidential data should be just that - confidential. In part, that means restricting access to the system, so only trusted members of your agency can log in via Azure AD. But it also means that, once those users have access, there's a robust trail of accountability. That's where our event audit logs come in; nothing can be watched, edited or deleted without your knowledge. And in addition to at-rest encryption, you can also restrict sensitive events so only certain users with the right permissions have access to them.

## SECURITY

Authentication	Use your Windows Active Directory credentials for a smoother, more secure sign-in process. Configure separate supervisor passwords to restrict access to your M500 in-car video system's administrative functions.
Encryption	All media is uploaded to, and stored securely on, VideoManager EL with AES 256 encryption.
Restriction	Restrict individual sensitive events on the system so only specific users with the correct permissions can view them.
Audit log	View a comprehensive, uneditable trail of all actions taken on a specific event.
Retention and deletion	Configure automatic, sophisticated deletion policies based on event category tags.
